Who would make a good volunteer?

#### Volunteering is something everyone can do

Anyone can be a good volunteer as we all have different experiences and skills to share, and we all have something we are good at. Here are some of the things we at Thirtyone:eight are looking for in our volunteers:

• Aged over 18

- Able to commit to a role, be available at the agreed times, and meet the requirements of the role
- Able to follow guidelines on confidentiality and safeguarding
- Communicate regularly with your volunteer manager and provide feedback, as required
- Willing to do a relevant background check (i.e. DBS, PVG, Access NI) and provide two names for a reference
- Be open, friendly and honest
- Support and be sympathetic to our vision, mission, and values

Our volunteers should be able to understand and follow the boundaries, policies and procedures of the organisation. All volunteers are expected to undertake an induction.

#### What about if I have a disability or medical condition?

As long as you meet the requirements of the role, we welcome your application. We will work with you to discuss any specific support needs, or consider any reasonable adjustments that will make volunteering with us accessible for you.

#### Can I volunteer if I have a criminal record?

As a safeguarding charity we have a zero tolerance approach to abuse and exploitation of vulnerable people, so carry out background checks on all potential volunteers, as part of our safer recruitment processes.

Having previous cautions or convictions does not automatically exclude you from volunteering with us. We will discuss these with you as part of the application process and consider each situation on a case-bycase basis, depending on the nature of the offences and the level of risk involved with the role.





# What can you expect from us?

#### What you can expect.

At Thirtyone:eight we value our volunteers highly and recognise that volunteering has two way benefits. As part of our commitment to our volunteers here's what you can expect from us:



- Regular communication
- Opportunity to work as part of a team
- Opportunity for Personal Development
- Opportunities to apply for internal job vacancies
- Reimbursement of travel expenses for mileage, train fares and bus fares up to £10 a day

#### Supervision and support

Informal supervision will happen regularly with your line manager and formal supervision will take place at least quarterly. These focus on you as an individual and not only help us understand how we can better help with your work and personal development, but also ensure that we are offering relevant, appropriate support.

#### Learning and development

All training relevant to the role will be given and you'll gain skills and experience working in a busy office. Through regular supervision, additional learning and development opportunities are highlighted. Where possible and appropriate, we ensure that your development needs are being met and also the charity benefits from that training.

#### Flexible working

We understand the importance of being at those significant 'red-letter' days. Where volunteers have committed to set days / hours, we will, of course, be flexible so that you can be at those important events.
